What is Title I?

Who is it for? All students and their families participating in the Title I/Part A program, are encouraged and invited to fully participate in the opportunities described in this plan. Sweetwater Elementary will provide full opportunity for the participation of families with limited English, families with disabilities, and families of migratory children.
